Introduction

This document is designed to help potential proposers find SSH-related topics across the different parts of Horizon Europe Work Programme 2023-25.

Social Sciences and Humanities (SSH) in Horizon Europe

Horizon Europe aims at fully integrating Social Sciences and Humanities (SSH) in each of its pillars. In particular, under the pillar 'Global Challenges and European Industrial Competitiveness', SSH should be fully integrated across all clusters. SSH is therefore a cross-cutting issue and integrated in the whole Framework Programme. While SSH research aspects are particularly present in Cluster 2 'Culture, Creativity and Inclusive Society', they are also present in all other clusters and in other parts of Horizon Europe.

Horizon Europe requires applicants to submit proposals and build consortia that transcend disciplinary and sectorial boundaries, bringing together scholars from SSH and from life and physical sciences, technology, engineering and mathematics (STEM), as well as researchers and practitioners across these fields.

The SSH encompass a wide range of disciplines such as sociology and economics, psychology and political science, history and cultural sciences, law and ethics. Contributions from these research and activity fields are needed under Horizon Europe to generate new knowledge, support evidence-based policymaking, develop key competences and produce multidisciplinary solutions to both societal and technological issues.

SSH-flagged topics across Horizon Europe

To assist SSH researchers in identifying funding opportunities, the European Commission (EC) has established a search engine within its online <u>Funding & Tender Opportunities Portal</u>. Certain topics with substantial SSH aspects have been "flagged" by the EC as SSH-relevant, and the search engine offers the option to quickly search for the specific priority 'Socio-economic science and humanities'. It also allows for keyword and full-text search.

This document compiles the "SSH-flagged topics" listed on the <u>Funding & Tender Opportunities Portal</u> and is based on the analysis of SSH-relevant topics carried out jointly by the thematic services and Unit D.3 Health & Societal Transitions of the EC Directorate-General for Research and Innovation. The document also includes a few additional topics that, while not flagged, may require the contribution of Social Sciences and Humanities researchers.

Researchers are strongly encouraged to screen the Work Programme themselves, in order not to lose out on research opportunities offered on their specific interest. In any case, all Work Programme parts need to be read in detail, in order to become familiar with the overall approach of the theme, the context of the topics, rules for participation, and other specific requirements. Of special importance are the "type of action" and the eligibility criteria connected to it. This and any other relevant information can be found in the specific Work Programme part and the specific call document. All relevant documents can be downloaded from the Funding & Tender Opportunities Portal. The specific links are provided for each topic in the respective chapters.



Structure of the document

The structure of this document is determined by the degree of anticipated SSH integration in the different Horizon Europe Programme parts. Instead of following the numerical order of the Horizon Europe Pillars (I. Excellent science, II. Global Challenges & European Industrial Competitiveness, III. Innovative Europe), the document starts with the part that includes "top down" topics and the greatest amount of SSH research dimensions: the thematic Clusters under the second Pillar. The document continues with the Excellent Science programming areas (mostly "bottom up" opportunities), followed by relevant topics located in the Innovative Europe programming area. In the last two chapters, the SSH-relevant topics in Widening Participation & Strengthening the European Research Area and in the Missions are presented.

An important feature of this guide is a "main keywords" reference section that is included as part of each listed topic. This feature is a short-hand reference naming the type of social scientific or humanistic science-related research know-how, methodology, or disciplinary framing technique required for successful project implementation. These keywords are an adaptation of the <u>Marie</u> <u>Skłodowska-Curie Actions (MSCA) Keywords</u> and the Social Sciences and Humanities categories used by the European Commission in the Monitoring reports on the <u>Integration of Social Sciences</u> and <u>Humanities in Horizon 2020</u>. The use of "main keywords" serves to help clarify how to locate one's research discipline in the context of a topic's research requirements.

Information on calls might be subject to change. To receive the latest information on calls, researchers/users of this guide need to consult the Funding & Tender opportunities Portal to inform themselves of any updates.
